042401 Welcome

The chairman welcomed all to the meeting

The council resolved to accept the minutes of the 26th March 2024 meeting as a true and accurate record. The chairman signed the minutes

042408 Quickline Donation to the playing field improvements

To discuss receipt of the promised funding with Quickline representative

Agenda item was moved forward.

Working group member explained they are personally out of pocket due to shortfall in promised funding from Quickline, was originally informed that a donation would be made for every household that signed up for a Quickline contract and no monies have been received, instead there has been an offer of vouchers which are unusable towards the play equipment project.

Quickline representative explained that promised cash funding has not materialised due to employee changes and company process not being followed. Quickline confirmed that the parish council may be required to sign a funding agreement.

All parties welcomed a solution, Quickline representative confirmed contact would be made within a week to confirm the number of sign ups and offer of funding to the working group.

Cllr Thrall raised concerns about the recent collisions on the A1041, Cllr Crane is in discussions with North Yorkshire Highways about the dangers on this road in attempts to get improvements.

Lawful development certificate for existing use of land for fishing purposes

The Parish Councillors were of the impression that the site had been used for fishing purposes for years but could not confirm. Resident suggested speaking to fishing license enforcement as they should be able to track fishing locations. Concern was also raised about removal of trees within the nesting season.
