# BARLOW PARISH COUNCIL MEETING Tuesday 30<sup>th</sup> September 2025 7pm Barlow Village Hall

#### 092501 Welcome

The chairman welcomed all to the meeting

#### 092502 Public Forum

To receive comments from members of the public – residents in attendance came to explain about the newly erected fence on the park lane playing field, the land has been purchased from Drax.

### 092503 Apologies

Apologies received from Cllr Edmunds, Cllr Fenteman was not in attendance

#### 092504 Approval of minutes

The council resolved to accept the minutes of the 29<sup>th</sup> July 2025 meeting as a true and accurate record The chairman signed the minutes, and those of 24<sup>th</sup> June 2025 due to the clerks absence at the last meeting

### 092505 To receive report from, and agree any actions:

- a) Chairman no update other than covered by the agenda
- b) County Councillor Cllr Crane informed the council that the St Georges/GB flags that have been attached to lampposts will now be removed. Permission is required to attach objects to council owned lampposts. Miniroundabouts have also been painted with the St Georges cross and these have been repainted. Cllr Thrall queried solar farms and the requirement to reinstate land to previous state, suggestion was made to utilise bonds for this purpose. Cllr Banks raised complaint regarding the narrowing of camela lane due to the new fence around the solar farm. Cllr Crane confirmed there has been no update on the unauthorised caravan.
- c) Burial Authority Cllr Spofford confirmed water pipes are under the cemetery and plans are being purchased to identify the exact location. Cllr Donoghue has resigned from the burial authority due to work commitments.
- d) Village Hall Committee finances are the main concern with limited bookings since the nursery left
- e) Drax Cllr Thrall attended recent meeting; BECCS may not go ahead, government may reduce the purchase of electricity to 40% of current amount, more contracts have been sought to move ash from the mound. Cllr Spofford has noticed black spots on windows, suspicion that this may be due to the movement of ash. Cllr Thrall to raise with Drax air quality checks.
- f) YLCA Cllr thrall attended recent meeting. Discussions around community assets which prompted the review of government guidance in relation to the Drax land under lease.
